Grey Cup champion with local ties shares about memorable season

While many in Saskatchewan sport the green and white when it comes to the Canadian Football League, there are some who live in the province who proudly wear the blue and gold. So after waiting 29 long years between championships, when the Winnipeg Blue Bombers defeated the Hamilton Tiger-Cats in the 2019 Grey Cup, there was a lot to cheer about for the team's players and its supporters.

Originally from Regina and suiting up for the Riders before being traded to Winnipeg in 2013, Pat Neufeld was one of those players able to relish in the moment of winning a cup in 2019. After missing out in 2013, the partner of Paula Sather (who was raised on a farm near Watrous) said when he finally got to hoist the cup, it was a surreal feeling.

"It was a little point of pride in being from Saskatchewan and having them trade me in their Grey Cup season, especially after thinking that was going to be my home for a good portion of my career," said Neufeld from his residence in Saskatoon. "The Bombers organization has treated me so well. I have loved being a Bomber and I wanted nothing more than to win it with them. It was just such a great feeling winning it with those guys and that organization."

Despite leaping out of the gate in 2019 with a 9-3 record, injuries at critical positions took a toll on the team and the blue and gold were 2-4 for the remainder of the regular season. Eventually finishing third with a record of 11-7, a trade deadline acquisition to bring in former Rider quarterback Zach Collaros aided in turning things around.

"When he came into our building, he assured all of us that he was good to go," said Neufeld recalling the big move. "We got the full meal Zach in practice. He was practicing really well and was spending a ton of time in the facility, going above and beyond just to learn our system and learn the way we were operating. He came in and played lights out and our defence played tremendous throughout the end of the season and in the playoffs."

Noting how the team had an incredible plus 13 turnover ratio, which ultimately

set the tone throughout the post-season, Neufeld said things really came together. "We played our best football at our most critical part of the season. We worked really hard and ended up winning that championship, not just for the organization but for Bomber fans everywhere who had long suffered 29 years of not winning."

For players like Pat, who narrowly missed out on raising the trophy in 2013 and had to come back from injury in 2019, the feeling of winning the big game against Hamilton proved to be a monumental effort. "I won a provincial championship in high school and that was awesome. You don't really understand what it means then. You are just playing football with your buddies from high school and we were lucky enough to win it in my Gr. 12 season. I was part of the team that played in the championship game in college but we lost it and I didn't get in a championship game again until 2019 so it was definitely sweet to savour."

That moment of winning Grey Cup 107 in Calgary on Nov. 24, 2019 will not only be one for the ages but will forever be etched in Neufeld's mind. Despite being forced off the field this season due to the COVID-19 pandemic, when what would have been Grey Cup week 2020, Neufeld was able to relive the 2019 championship game.

"It was pretty awesome. Myself and a couple of teammates were watching the game and doing live commentary and I distinctly remember feeling just a massive sense of relief when we won the Grey Cup. As soon as the final whistle blew it was sheer joy and I was hugging my teammates. Then a sudden calmness came over me and I was watching the confetti fly. Then I was finding my family and I just felt this massive sense of relief that we finally did it and this massive gorilla is off our backs. People can't say anymore, 'When are you guys going to do it? I've been waiting so long.' After the relief, I just started taking it in and was in such a celebratory mood. I was able to celebrate with teammates and the organization."

Recalling last year's celebrations, after returning from Calgary with the trophy, members of the team spent a week taking

Saskatchewan releases COVID-19 vaccine delivery plan

Saskatchewan has developed a COVID-19 Vaccine Delivery Plan, and will be ready to administer the vaccine when the first shipment

is received. Saskatchewan is working closely with the Public Health Agency of Canada (PHAC) which negotiates and procures vaccines directly with manufacturers on behalf of provinces and

territories.

The Vaccine Delivery Plan outlines Saskatchewan's phased approach to delivering the COVID-19 vaccination to residents starting December 2020, including an initial pilot of the delivery and storage of the Pfizer vaccine, a first phase focused on targeted vaccination of priority populations, and widespread access to the vaccine in the second phase.

Health Minister Paul Merriman said, "We are putting in place the human and financial

resources to successfully distribute vaccines and get Saskatchewan residents immunized against COVID-19."

Vaccines for approximately 1,950 people is expected to arrive by Dec. 15, 2020. The pilot will see the vaccine administered at Regina General Hospital and delivered to health care workers providing direct care to COVID-19 patients. The first recipients of the COVID-19 vaccine will be health care workers in ICUs, Emergency Departments and Covid Units at Regina General and Pasqua Hospitals and staff

at testing and assessment centres. Pilot recipients will receive their second dose 21 days following the administration of the first dose (during Phase 1).


The Vaccine Delivery Plan's first phase focuses on immunizing priority populations who are at a higher risk of exposure to the virus or more at risk of serious illness - health care workers, elderly residents in care homes, seniors over 80 and residents in northern remote communities. Phase 1 is anticipated to commence in late December 2020 with 202,052 doses expected within the first quarter of 2021. This includes expected weekly

allocations of 10,725 doses of Pfizer vaccine. Weekly allocations of Moderna are currently being finalized. Allocations are subject to fluctuate and may affect sequencing plans. Updates will be provided.

The second phase of the Vaccine Delivery Plan is anticipated to commence in April 2021 and will continue priority population immunization while providing widespread vaccine access to immunize the general population. Distribution in Phase 2 will occur throughout the province at public health clinics and other vaccination delivery sites across the province.

Plans are in progress around safe storage of vaccines, sequenced distribution across the province, public communication of vaccine availability, contingency planning and statistical reporting of vaccines administered.

Also included in the Vaccine Delivery Plan is information regarding a significant public relations campaign to ensure accurate and timely information is provided to the people of Saskatchewan.

Chase the Ace 2020 holds final draw

There were no celebratory noise-makers blasting away, no jam-packed bar with patrons cheering boisterously, but there was prize money awarded as the Watrous Manitou Beach Heritage Centre Chase the Ace 2020 fundraiser held its third and final draw Dec. 4th at TB's Bar & Grill. Bob and Marilyn Wignes held the lucky Ace Jackpot ticket valued at \$1,497 and Gary Bergen won the weekly cash prize of \$62. Including the two draws held in March, a total of \$2,495 was awarded as cash prizes during the abbreviated Heritage Centre fundraiser.

Bergen's ticket was the first ticket pulled from the draw drum which automatically gave him the \$62 weekly cash prize. All eyes were on Dave Somers, the official fundraiser proxy, as he reached for a card from the deck of playing cards on behalf of Bergen. There would be no Ace Jackpot win for Bergen on this night as the two of Spades was selected rather than the sought-after Ace of Spades.

Twenty-one additional tickets were drawn and cards selected before Somers was able to find the Ace of Spades in the diminished deck of cards to correspond with the Wignes ticket. The Ace Jackpot prize is not valuable enough to purchase a round-the-world trip, but that's okay because this is 2020 and non-essential travel to anywhere is not recommended. Instead, the \$1,497 will make a nice Christmas present for the Wignes couple.

The quiet evening was a rather fitting end to the Heritage Centre's 2020 fundraiser which had got off to such a rousing start with a very successful ticket sales campaign kick-off at the Manitou Beach Winterfest celebration on Feb. 29th. Less than three weeks later, following two fun-filled evening draws Mar. 6th and 13th, the coronavirus arrived resulting in the government imposed restrictions and heightened concern regarding the health of people everywhere.

The Chase the Ace committee, not wanting to needlessly jeopardize the health of anyone associated with the fundraiser, decided to suspend the fundraiser before the Mar. 20th weekly draw was to be held. Tickets purchased for the Mar. 20th draw would be held until the next draw, whenever that might be. At the time, it is doubtful anyone expected the suspension to last until the licence expired. Committee vice-chair Glenda McArthur and co-chairs Lionel Sproule and Lyle Emmons held discussions from time to time to consider resumption of the fundraiser, but they continually determined it was best to leave the fundraiser mothballed.

The Chase the Ace licence was set to expire Dec. 4th, 2020. Before the expiration of the licence, the prize money that had accumulated through ticket sales had to be awarded, therefore, at least one more draw night had to be held. The committee met Oct. 30th where it was decided the final draw would be held Dec. 4th and only the tickets purchased in March for the suspended Mar. 20th draw would be entered in the draw.

Despite having only three draws, this Heritage Centre

fundraiser could not have been organized and operated without the assistance and contributions of many people. As Emmons was conducting the Dec. 4th draw, which was live-streamed online, he alluded to how the community fully supported the fundraiser. Locals also showed their strong support by purchasing tickets, but important as they are, it takes more than ticket buyers to host a successful fundraiser.

Emmons acknowledged the efforts of other groups and individuals who contributed significantly to the fundraiser, namely: Lane Manson and his staff at TB's Bar & Grill; the two official fundraiser proxies Dave Somers and Les Schuster; the 20 individuals who volunteered to sell Chase the Ace tickets; the eight local locations and their staff members who sold Chase the Ace tickets during office hours, including Watrous Pharmacy, TB's Bar & Grill, Affinity Credit Union, Watrous Mainline Motor Products, Centennial Ford Sales, Manitou Mainline Chrysler, Town of Watrous Administration Office, and the Heritage Centre; the Manitou Beach Recreation Board for allowing the ticket sales campaign to kick-off at Winterfest; and, the 16 Chase the Ace committee members as well as the three other individuals who assisted the committee.

Considering the length of time the fundraiser was suspended, it is truly a testament to the support received from the community that the fundraiser is going to make a very slight profit, approximately \$360. During the final draw Emmons stated the fundraiser would have been deep into the red ink without the financial sponsorship received from Melron Service Ltd. Emmons extended a special thanks to Ron Ediger and his late wife Melissa, owners of Melron Service, for fully paying the major cost associated with printing the Chase the Ace tickets.

Even with excellent community-wide support, sometimes a fundraiser gets derailed by the most unlikely of things, a coronavirus pandemic in this case.

Despite blowing a huge hole in the fundraiser's bottom line, the pandemic did not diminish the significance of the commitment and contributions made by the many volunteers associated with the Heritage Centre fundraiser.

The following 20 individuals volunteered to sell Chase the Ace tickets for the committee: Shelley Engele, Melanie and John Gunderson, Janis and Ray Hall, Deb Holm, Melanie Manson, Karen and Fraser Mark, Ruth and Ron Morningstar, Sherwin Petersen, Joyce and David Potts, Cathy Sather, Denise Thoner, Cindy and Keith Vanthuyne, Kerry Van Vaals, and Connie Woiden. The suspension of the fundraiser after only two draws meant some of the volunteers were not afforded the opportunity to sell tickets.

Saskatchewan RCMP COVID-related calls for service to date

From Mar. 1, 2020 to Nov. 30, 2020 the Saskatchewan RCMP received a total of 3,300 COVID-related calls for service. Of those, 49 have resulted in charges.

The vast majority of COVID-related calls for service were resolved by educating individuals

about the Public Health Orders (PHO) in place and the potential health and enforcement consequences that can result from non-compliance with the PHO. As police officers, officers are responsible for ensuring their actions do not put others at risk while doing their part to slow the spread of the virus. "We need you to do the same and this starts by following and familiarizing yourself with the PHOs."

Calls for service and charges for the month of November: from Nov. 1 to 30, Saskatchewan RCMP received 342 COVID-related calls for service:

- 128 complaints of individuals not self-isolating;
- 92 large gathering complaints;
- 20 masking complaints;
- 14 traveller check complaints; and
- 88 other COVID-related complaints.

Of these calls for ser-

vice, police have charged seven individuals under the province's Public Health Orders for contravening Sec. 61 of The Public Health Act, 1994. The location of the charges are identified in accordance with the provincial government's COVID-19 map, which provides detailed information on the location of cases across Saskatchewan divided into 13 zones.

There were four charges to individuals not self-isolating despite being advised to do so by local health authorities. These charges occurred in the following zones: Far North West, two in the North Central, and one in the Far North Central.

There were three charges to individuals for large gatherings. These charges occurred in the following zones: Far North East, Far North Central and Far North West.

Each charge is a Summary Offence Ticket Information (SOTI), under a Provincial Statute. These charges are not a criminal offence. For this reason, the names of the individuals charged will not be released.

As Saskatchewan's provincial police force, members will continue to

be present in communities to provide services and ensure community safety 24 hours a day, seven days a week. Police continue to work closely with Saskatchewan Health Authorities to investigate calls for service that violate the PHO to help maintain public health and safety.

To support the steps communities are taking to reduce the spread of COVID-19, detachments in areas with an increased number of positive COVID-19 cases may temporarily restrict public access to the detachment to emergency requests for service only. As a result, RCMP encourage people to phone their local detachment prior to visiting in person to determine if any changes are taking place. Crime Watch Advisory Network Expanded

Saskatchewan's Crime Watch Advisory Network

has been expanded to include municipal police services and conservation officers. The Network allows police services to issue advisories to residents via text messages, emails or phone calls with information about criminal activity in their area.

"The expansion of the Saskatchewan Crime Watch Advisory Network will increase communication and engagement between citizens and law enforcement," Corrections, Policing and Public Safety Minister Christine Tell said. "It's a safe, reliable, and efficient service that will help keep our communities safe."

The expansion will add the following agencies:

- Weyburn Police Service;
- Moose Jaw Police Service;
- Prince Albert Police Service;
- Wilton Police Service;
- Corman Park Police Service;
- Dalmeny Police Service; and
- Ministry of Environment/Conservation Officer Service.

The Government of Saskatchewan provides approximately \$50,000 annually for the RCMP to operate the Saskatchewan

Crime Watch Advisory Network.

"The Saskatchewan Association of Chiefs of Police supports the Saskatchewan Crime Watch Advisory Network fully," Saskatchewan Association of Chiefs of Police President Chief Rick Bourassa said. "Through this valuable program, police services and people in our communities are able to work together even more quickly and effectively to advance community safety and wellbeing across our province."

The Network was first used by RCMP in the southern part of the province, and has gradually been adopted by more law enforcement agencies.

To date, law enforcement has received tips from the public in response to numerous advisories. Often, the tips are instrumental in the swift resolution of cases, ranging from vehicle theft to fraud.

Close to 15,000 citizens have already registered to receive crime watch notifications from the RCMP, which issued more than 900 advisories.

Chase the Ace ticket sales started incredibly well at the Manitou Beach Winterfest on February 29 followed by two weeks of successful sales until the coronavirus arrived in March and our world changed. The Chase the Ace committee did not want to potentially jeopardize the health of anyone associated with the fundraiser so the project was suspended March 19 until December 4 when the third and final draw was held. Only tickets previously purchased for the March 20 draw (which was not held) were entered in the December 4 draw. How times change. When Justin Trudeau was first elected, he promised to set new standards in transparent government. He has set a new standard, all right ... in how not to be transparent.

Last week, the government issued its Fall Economic Statement. The name was carefully chosen since it did not meet the level of detail that we would normally expect from a fiscal update. Dear Reena,

We live in a 1930s heritage home and there is natural tile in front of the fireplace. Unfortunately, the tile has been scraped by the bottom of a chair. We have tried to fix it but with no luck at all. Would you have a suggestion for us? Robert

you say it is done. Begin by purchasing or borrowing an inexpensive thermometer to test your oven temperature. Check baking 10 minutes before the recipe states, if the toothpick comes out clean, baking is complete. If baking is browning too quickly on top, cover it with foil.

Dear Reena,

How do I clean road salt stains from my rubber car mats? I tried vinegar and it does not clean very well. Bill

Dear Bill,

Begin by beating the mats with a broom to remove most of the loose dirt and dust. Next vacuum the mats until no dirt remains. Using either dish soap or carpet shampoo and water, create lather and distribute onto the salt stains, scrub with a stiff brush. Rinse and let air dry.

Tasty Turkey Tips:

- Before cooking turkey, defrost the meat in the fridge. Leave the turkey at room temperature for one hour before roasting to ensure that it cooks evenly.

- Make your own garlic butter to add wonderful flavour to your turkey. Finely chop one tablespoon of each of the following: fresh rosemary, thyme and sage. Add two cloves grated garlic. Season with salt and pepper. Add one cup room temperature softened butter. Stir all ingredients together. Loosen the skin of the turkey and take three quarters of the garlic butter and rub it between the skin and the meat. As the butter melts it will flow throughout the turkey while cooking. Stuff any remaining herbs into the cavity of the turkey along with chopped carrots, onion and celery. Smear remaining garlic butter on the outside of the turkey.

- Before cooking, pour chicken stock around the turkey. Baste every 30 minutes.

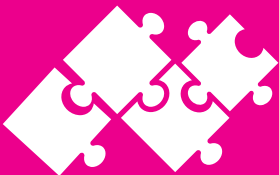



Chocolate Dipped Pretzels

Ingredients:

White chocolate melting wafers or white chocolate chips
small shaped pretzels

Directions:

Melt the wafers over low heat until melted, or melt at 50 percent power in a microwave. Start with 40 seconds on 50 percent power, stir, then microwave at 20 second intervals, stirring between each until the chocolate is melted. Dip the pretzels into the chocolate, coating one side with the chocolate, let excess drip back. Place on waxed paper or parchment paper to cool. You can also use regular chocolate chips but we love the sweet/salty of the partially coated pretzels using the white chocolate.

Gingerbread People

Ingredients:

1/2 cup shortening
1/2 cup brown sugar
1 egg
1/2 cup molasses
1/4 cup water
2 3/4 cup flour
1/2 tsp. baking soda
1/2 tsp. salt
2 3/4 tsp. ginger
1/2-1 tsp. cinnamon
1/4 tsp. allspice

Directions:

Cream shortening and sugar. Beat in egg, then molasses and water. Blend the dry ingredients and add to this mixture. Cover and chill in fridge 1/2 to 1 hour. Roll on floured surface about 1/8 to 1/4 inch thick. Decorate with candy or raisins. Bake at 350°F for 8 to 10 minutes on a greased cookie sheet. When I use this to make larger gingerbread people or to make gingerbread houses, I always roll about 1/4 inch thick.

the Grey Cup to a few places in Winnipeg and parading it around the city. Neufeld figures at the official parade at least half of Winnipeg turned out. He also travelled to nearby Brandon, taking the trophy to a few high schools and to a Brandon Wheat Kings' game. "We ended up signing autographs for two out of the three periods so it was really great to see the reception."

That celebration would eventually extend past the Manitoba border to Saskatchewan where

Paula and her family were able to enjoy time with the historic Grey Cup as well. Calvin and Cathy Sather farm near Watrous and while once avid Rider fans, as Paula started dating Pat, the green and white colours eventually turned into blue and gold. Along with Paula's parents, her brother Brent and his wife Catherine and their kids all cheered on Pat as he won the Grey Cup.

"They are such a big support," said Neufeld of the Sather family, adding he still gets a little emotional talking about the opportunity they all had to spend time with the Grey

Cup. "To me it is such a great trophy and I have such reverence for the trophy so being able to share it with her family, my family and take pictures that we can all look back on and say how cool it was to have this 107 year old trophy in our backyard, drinking out of it, and taking pictures with it; it was just a real cool experience."

Since there was no season in 2020, when asked if he considers the Bombers defending Grey Cup champions, Neufeld remarked, "I am really wondering what they will do with 2020. Maybe they will have a plaque on the Grey Cup and it is going to be like, 'Not played due to COVID' or if we are going to be on their twice. I am not sure what is going to happen with that, so we will say we are still the defending champs."

While Neufeld is fine with remaining a defending

Grey Cup champion, he would have rather tried to defend the title in 2020 and not have had to sit out because of the pandemic.

With football such a big part of his life, once the season was officially cancelled in August, Neufeld said it was difficult to hear.

"It has been hard, I'm not going to lie. For me, football is just such a massive part of my life and our family life here. It is like cyclical and routine. Like this point in the offseason we are doing this, this point in the off-season we are doing this and then we are going to Winnipeg and that kind of thing. When this whole thing happened it was getting close to training camp and I wasn't sure if camp was going to happen. I was still training like training camp was going to happen."

Despite all of the circumstances due to

the pandemic, like other players and coaches, Neufeld continues to keep busy. Right now he is doing a bit of work in Saskatoon but hopes to get back on the field sooner rather than later.


"I love the CFL. I love the league and the tradition. Just the community feel around the league, it is a fan-driven league and there is so much fan and player access. I grew up as a fan and I really hope we get a chance to come together in stadiums and be able to watch the game and celebrate this great sport and this tradition of history. Just to be able to watch the game and play the game that I love with some great friends and the community would be cool."

So when the CFL released its tentative schedule for 2021, Neufeld had a renewed sense of excitement. "When that schedule came out, me

and a bunch of teammates started texting about a short week here, a long week here, we have this team and this team back to back, so already we are starting to scheme up so it is pretty cool."

Hoping that the schedule means more positive things to come, the lineman shared about the value of seeing the league return for everyone.

"I am probably speaking for 99 percent of CFL players when I say this but we miss playing the game and playing in front of such great fans. Having Grey Cup week is such a great Canadiana experience where people from all across this country get to come together and celebrate a game, even if your team is not even playing. Hopefully in 2021 we can get an opportunity to come back and play and get back to some kind of normalcy."
