Q and A with the previous and current mayor of Watrous

As 2020 comes to a close, this past year also saw a chapter end and a new one begin in Watrous. As municipal elections took place, now former mayor of Watrous, Ed Collins elected to step away from his position after serving for a number of years. That role was filled by former councillor and longtime resident of the community, John Gunderson.

The Watrous Manitou reached out to both who graciously shared a bit about themselves, some highlights of being a part of council, what is ahead for 2021 and a few other things. The following are the responses from both Collins and Gunderson.

Former Mayor of Watrous Ed Collins

For those who may not know you, tell me a bit about yourself and how you arrived in Watrous.

I was born in Melfort in northeast Saskatchewan and lived in a number of smaller communities before graduating from high school in Bjorkdale. I started my work life in Melfort, first working for the Sask. Department of Highways for eight years and then working for the Sask. Liquor & Gaming Authority for the past 42 years where I am still employed as a District Manager. This past July marked 50 years of employment with the Government of Saskatchewan.

I moved to Watrous in 1986 with my family to become the Liquor Store Manager. My wife Linda and I have three sons, three wonderful daughters-in-law and six grandchildren. We all reside in the great community of Watrous.

Since moving to Watrous I have been involved with a number of organizations over the years including the Chamber of Commerce, Kinsmen Club, K-40 Club, coaching minor sports teams, being an avid supporter of the Watrous Winterhawks and of course a part of Watrous Town Council.

When were you first elected to council?

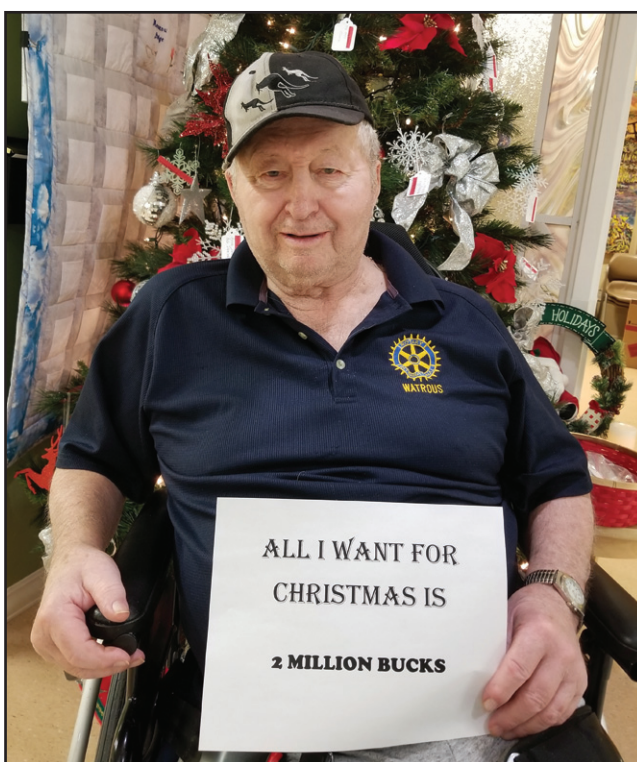
I was elected to Watrous Town Council as a councillor in October of 1988 and served nine years in that capacity under the leadership of Murray Westby, whom I had a great deal of respect for and learned a great deal about civic politics.

After Murray stepped down as mayor in 1997, I was elected mayor, a position I held until the fall of 2020.

Public notice is hereby given that the Council of the RM of Prairie Rose intends to consider the adoption of a bylaw under *The Planning and Development Act, 2007* to adopt a new Official Community Plan.

INTENT

The proposed bylaw establishes municipal land use policies including, but not limited to, the following subjects: **Natural and Heritage Resources:** Identify and protect natural features, ground water, historical and heritage resources, and ensure development happens in an environmentally sustainable manner.

Biophysical Considerations and Hazards: Regulation for development on and near hazardous lands, including environmentally sensitive lands, contaminated lands and flood hazard areas. Ensuring source water protection and public safety.

Commercial and Economic Development: Support for compatible commercial development, and provide provision for minimizing land use conflicts.

Municipal Infrastructures and Services: The integration of planning, finance and engineering to manage infrastructure effectively, providing connectivity and traffic safety for all users, while ensuring that future development contributes appropriately to the cost of infrastructure services.

Intermunicipal and Interjurisdictional Cooperation: Pursuing opportunities with government to enhance services and provide innovative opportunities for the region, and facilitation of interjurisdictional cooperation with neighbouring municipalities, First Nations, and other stakeholders on joint planning issues.

Agricultural Land Use and Development: Protection of prime farm land within the RM while allowing for diverse forms of agricultural development.

Residential land use and development: Identify existing and future residential development areas, support infill development, and ensure the preservation of agricultural land.

Recreation and Tourism: The development and enhancement of recreation and community services within the RM, preservation of natural areas and ecosystems, and support for public service delivery agencies.

Implementation: Policies regarding the implementation of the Official Community Plan and the application of tools within the Zoning Bylaw for subdivision review, dedication of lands, the use of a Building Bylaw, and the use of Development Levies and Servicing Fees. The Official Community Plan also contains a development considerations and constraints map which graphically displays, in a conceptual manner, the present and intended future location and extent of general land uses in the RM. This map will assist in the application of general goals, objectives and policies of the Official Community Plan. The

policies in the Official Community Plan will be implemented primarily through administration of the RM's new Zoning Bylaw.

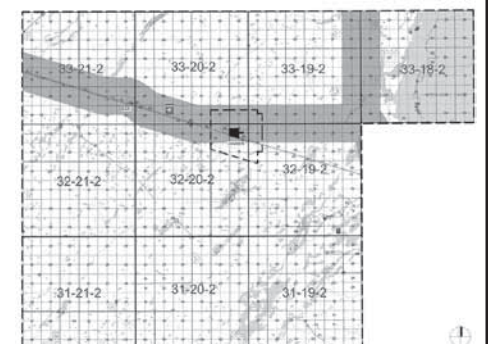

While Saskatchewan's COVID-19 case trends are relatively stable, case rates continue to create significant, on-going community transmission and increasing pressure on health care services. Additional public health measures are being introduced based on the transmission patterns observed in Saskatchewan.

Public Health Orders

These public health measures are in addition to those in effect as of Nov. 27, 2020. All public health measures will remain in effect until Jan. 15, 2021. At that time they will be reviewed by the provincial Chief Medical Health Officer.

• The public health orders for licensed establishments; sports, fitness and dance; places of worship; and mandatory masking remain in place.

• Public health continues to emphasize working from home, whenever possible.

• Public health continues to strongly recommend that only one member of a household do required shopping, and limit shopping to essential items as much as possible.

• All non-essential interprovincial travel is discouraged.



with Impaired Driving following an investigation by Saskatoon Police Patrol and members of the Collision Analyst Unit to a collision that occurred shortly before 8:30 p.m. Dec. 14 on Circle Drive at Taylor St. E. in Saskatoon.

A northbound car on Circle Drive rear ended another car before colliding with a pickup truck that was also northbound on the on ramp from Taylor St. The force of the collision caused both cars to roll onto their roofs and one to end up in the south bound lanes.

The 17-year-old female driver of the car that was rear ended was treated at the scene and released. The 45-year-old male driver of the pickup was not injured.

The 48-year-old male was transported to RUH by ambulance with non life threatening injuries. He has been released from custody to appear in court at a future date. More charges are pending.

Truck involved in reckless driving in Watson

On Dec. 8, 2020 between the hours of 7 and 8:30 p.m., a red Chevrolet truck was reported driving recklessly in the Town of Watson by preforming donuts and fishtailing around corners. The driver of the truck was yelling and gesturing obscenities at sev-

eral community members in the community during this time.

Drug trafficking investigation leads to significant drug seizure

On Wednesday, Dec. 9 officers from the Saskatchewan RCMP Federal Serious and Organized Crime Unit North (FSOC-N) were conducting an ongoing drug trafficking investigation in Osler.

Information obtained by the Saskatchewan RCMP FSOC-N led to the execution of a search warrant at a residence located on the 200th block of Parkview Cove in Osler.

A search of the residence resulted in the seizure of the following drugs and items:

- 1,448 grams of suspected methamphetamine;
- 476 grams of suspected cocaine;
- 278 grams of suspected fentanyl;
- \$4,445 in Canadian

currency;

- .32 caliber handgun and ammunition; and
- paraphernalia consistent with drug trafficking.

The quantity of fentanyl seized could be broken down into approximately over 1,000 individual doses. Fentanyl is odourless and tasteless, and therefore hard to detect.

A lethal dose of pure fentanyl is potentially less than two milligrams – that is equivalent to about two grains of salt.

As a result of this investigation, completed by FSOC-N with assistance from the Prince Albert Integrated Crime Reduction Team and Warman RCMP, 28-year-old Dustin McDougall from Osler has been charged with the following offences:

- Three counts of Possession for the Purpose of Trafficking contrary to Section 5(2) of the Controlled Drugs and Substances Act;
- Possession of Proceeds of Crime Under \$5000 contrary to Section 354(1) of the Criminal Code;
- Failure to Comply with Court Order contrary to Section 145 of the Criminal Code; and
- Three firearms related offences contrary to Sections 86(2) and 91(1) of the Criminal Code.

Dustin McDougall was scheduled to appear in court on Dec. 11, 2020 in Saskatoon.

“When we look at the impact of drug trafficking in our communities, we see the regular use of violence and property crime. These are just some of the many illegal activities that ruin lives every day. Preventing illicit drugs from spreading even further in our communities, plays a huge role in maintaining public safety,” said Staff Sergeant Jason Kerr, of the Saskatchewan FSOC-N. “The presence of illicit drugs and fatal overdoses are occurring in small towns and rural areas – this is not strictly a big city issue. Anyone can feel the dangerous impact of drugs when it reaches their community.”

The Saskatchewan RCMP Federal Serious and Organized Crime Unit works in conjunction with domestic and international partners to disrupt, dismantle and support the prosecution of serious and organized crime groups and their members.

If you have information about people trafficking drugs, you can report it to your local RCMP detachment or police service. If you wish to remain anonymous, you can report it to Crime Stoppers at 1-800-222-TIPS.

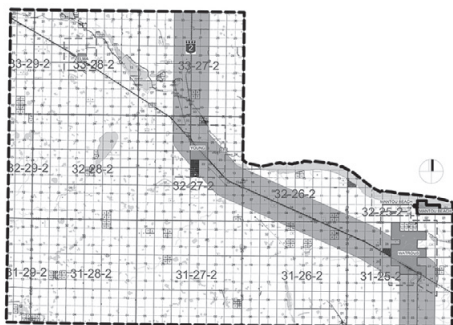

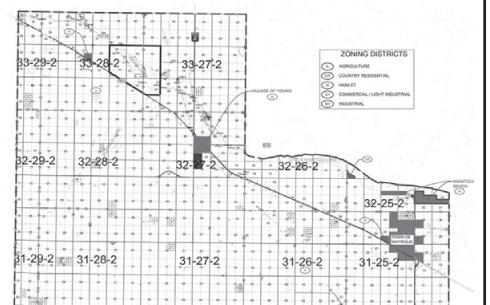

A COVID Christmas

Ever had the feeling that the rug was pulled out from under you? Many of us will likely feel like this, in this holy season of love and belonging and God-with-us. We are hunkered down at home instead of gathered with family, at the most visiting with familiar faces in little boxes on a Zoom screen. We watch Christmas movies and listen to Christmas carols instead of singing our hearts out in church. We are lighting lonely candles instead of basking together in God’s light of love and joy and peace in Christ Jesus while singing Silent Night. Let us face it: Christmas sucks this year.

Everything that has given us purpose and meaning — the rituals of life and death, the ways we go about relationships and maintain community, the security of jobs and the satisfaction of pursuing dreams and ambitions — has been snatched away by something we cannot even see. Ten months in and we face yet another special holiday that will not be as it once was. It is unnerving and unsettling, upending and upheaving — suspending us in that in-between space caused by pandemic and protest, by disbelief and resentful compliance, by resistance and revolution. How we long for that “once was” time — nostalgia is persistent, particularly when uncertainty reigns and we feel out of control.

Where is the blessing, where is the joy, where is the hope? We might even find ourselves asking, “Is what I believe about God still true anymore? Is my faith strong enough to weather this existential storm?”

But could it be . . . Could it be that maybe this is why Christmas comes every year, to remind us, once again, that the normal we create is not the normal God wishes for us? As Christians, we ought to know this time well — the time between the already and the not yet of God’s reign. The time between God so loved the world and waiting for it to come true. The kind of time that Mary understood so well. The kind of time trembling with the tension between “How can this be?” and “Nothing will be impossible with God” (Luke 1:34, 37).

How can all this possibly be happening? It is an age-old question, and it is a question that could in fact bring us closer to the true meaning of Christmas. Mary herself felt that question deep in her own heart and bones, “How can I possibly be pregnant? How can this be?”

There is no going back to normal; Mary knew that. She realized this truth as she found herself with child from the Holy Spirit. For Mary, there was no going back to normal once she gave her “yes.” There was no going back to normal once the Word became flesh in Christ Jesus. There was no going back to normal when Jesus called the disciples and they left everything. There was no going back to normal for the lepers, the infirm, the outcasts, once Jesus touched their hearts. There was no going back to normal when the women found the tomb empty. There was no going back to normal when Jesus sent his disciples into all nations to be Good News for all. What we settle for as normal is vastly different than what God envisions as normal.

Before Christmas became presents and pageants, dinners and decorations, Jesus’ birth was a threat to those in power. It was a threat to those who hoarded their own comfort and privilege at the expense of the disposable masses, and it is still that way. The message of God becoming one of us in Jesus is still dangerous. Indeed, just like COVID-19, Christmas was unprecedented, upending what the world had settled for as normal. God’s love borne in the flesh through Jesus unleashed a bug too, an invisible bug of healing and mercy, joy and reconciliation, invading the world, landing in open and hurting and yearning hearts — invisible, yet more powerful than anything the world had ever seen. And despite COVID-19, that love-bug is still with us, pulsating in eager hearts to reach out in compassion and joy and love, inching towards God’s reign of peace and justice.

This Christmas will not be “normal” for any of us. But it just might be like that first Christmas, and we might find

Tips from Reena Nerbas

here is the reason why many people add rice grains to shakers. A few grains of rice added to salt shakers is a great way to prevent salt from clumping because rice is said to absorb moisture. Dear Reena,
I would like to bake a Christmas fruit cake for the first time. The recipes I have looked up online are big recipes and expensive. Is it possible to make half a recipe? One asks for five eggs (how do I divide)? Shirley

Dear Shirley,
The easiest option is to use three small eggs (instead of medium or large). The more technically accurate solution includes measuring. A large egg equals about three tablespoons of contents. If the recipe calls for both egg yolk and egg white, beat the egg and use one and a half tablespoons for the Christmas fruit cake recipe.

Dear Reena,
Please advise me on how to clean the black ceramic shower tiles in my shower; we have very hard water. I have used many products to try to eliminate the mineral deposits and soap scum but the tiles remain blotchy and stained looking after they have dried. Thank you. Barbara

Dear Barbara,
Whenever I want to freshen up old grout, I get a handy little piece of pumice stone. Pour some dish soap onto the pumice stone and wet it, then scrub the grout; looks wonderful. Next spray isopropyl alcohol onto the grout to prevent

mildew from growing and discolouring the grout (keep away from small children). Another option is to make a paste of Borax and water; scrub grout with an old toothbrush.

Dear Reena,
Thanks to a lazy dog owner, I stepped in a pile of you-know-what and I did not notice until the following day. After cleaning the mess up, the smell is lingering. The sole is a rubberized material used on walking shoes. I have scrubbed with a variety of products, but I cannot get rid of the smell. Do you have any suggestions? Thank you. Leslie

Dear Leslie,
If possible, toss the shoes in the washing machine and wash with heavy-duty detergent and hot water. If the shoes are not washable, scrub the bottom sole with an old toothbrush, water and quite a bit of whitening toothpaste. Soak the bottom sole in 50/50 vinegar and water.
